**5.2. Special hazards arising from the substance or mixture**

**Exposure hazards:** Highly flammable. In combustion emits toxic fumes. Forms explosive air-vapour mixture. Vapour may travel considerable distance to source of ignition and flash back. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Hydrogen fluoride (HF).
