4.1. Description of first aid measures

- Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin.

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Hydrogen chloride (HCl). Hydrogen fluoride (HF).
