**[Prevention]**

| <b>Ingestion:</b>    | Do not induce vomiting without medical advice. Call a physician or Poison Control Center immediately. **Immediate medical attention:**

WARNING: It might be hazardous to the person providing aid to give mouth-to-mouth respiration, because the inhaled material is corrosive. For severe burns, immediate medical attention is required. **5. FIRE-FIGHTING MEASURES**

**Suitable extinguishing media:** Dry chemical, CO<sub>2</sub> or water spray. Consult with local fire authorities before attempting large scale fire fighting operations.

**Specific hazards arising from the chemical**

**6. ACCIDENTAL RELEASE MEASURES****Personal precautions:**

Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.

**Personal protective equipment:**

Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).

**6. ACCIDENTAL RELEASE MEASURES**

**Emergency procedures:** In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and exercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

**Methods and materials for containment and cleaning up:**

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. Ventilate the area.

**Environmental precautions:**

Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

**7. HANDLING AND STORAGE**

**Precautions for safe handling:** Do NOT breathe gas, fumes, vapor, or spray. Manipulate under an adequate fume hood. Avoid contact with skin and eyes. May corrode metallic surfaces. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.

**Conditions for safe storage:** Store in corrosive resistant container with a resistant inner liner. Keep containers tightly closed in a cool, well-ventilated place. Store locked up. Keep away from incompatibles. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Avoid prolonged storage periods. Store under inert gas (e.g. Argon). Moisture sensitive.
